

## LEGAL AID CLINIC

### REPORT

- 1. WILL:** MRS. SUMAN CAME FOR ASKING SUGGESTIONS TO GET CERTIFIED COPY OF 'WILL' MADE BY HER FATHER-IN-LAW. WILL WAS NOTARISED BUT WAS UN-REGISTERED. SUGGESTIONS WERE GIVEN TO REGISTER THE WILL FOR OBTAINING THE CERTIFIED COPY OF SAME.
- 2. PROPERTY:** MR. SHARMA CONTACTED LEGAL CLINIC AND TOLD ABOUT TITLE DISPUTE OF PROPERTY. SUGGESTION WAS GIVEN FOR GETTING SEARCH REPORT OF HIS PROPERTY FROM THE CONCERNED BANK FROM WHERE HE HAS TAKEN LOAN.
- 3. RAPE:** A GIRL CALLED LEGAL AID CLINIC AND TOLD THAT SHE HAD BEEN RAPED WHEN SHE WAS COMING BACK TO HER HOME FROM TUITION. SUGGESTION WAS GIVEN TO FILE A POLICE COMPLAINT AGAINST THE ACCUSED PERSON.
- 4. INTERNSHIP:** IN A LEGAL-AID-CAMP, STUDENTS WERE GUIDED FOR COMMUNITY POLICING- AN INTERNSHIP PROGRAMME STARTED BY MINISTRY OF HOME & EXTERNAL AFFAIRS.
- 5. GROUND OF DIVORCE:** MRS. RITU CALLED LEGAL AID CLINIC, ASKING FOR GROUND OF DIVORCE. SUGGESTIONS WERE GIVEN THAT CRUELTY, HARASSMENT, DOMESTIC VIOLENCE ETC., ARE GROUNDS FOR DIVORCE.
- 6. HARASSMENT:** MRS. SMITA CALLED AND TOLD THAT SHE IS BEING HARASSED BY HER HUSBAND & IN-LAWS FOR GIVING BIRTH TO A GIRL CHILD, SUGGESTION WAS GIVEN TO FILE COMPLAINT AGAINST HER HUSBAND & IN-LAWS AND FILE FOR DIVORCE.
- 7. DOMESTIC VIOLENCE:** MRS. SNIGDHA CALLED AND TOLD LEGAL AID CLINIC THAT SHE IS BEEN SUBJECTED TO DOMESTIC VIOLENCE BY HER HUSBAND & IN-LAWS IN DEMAND OF DOWRY. SUGGESTION WAS GIVEN TO FILE COMPLAINT AGAINST HER HUSBAND & IN-LAWS AND FILE FOR DIVORCE.
- 8. PRIVATE HOSTEL FEES:** MS. SHIKHA ALONG WITH HER FATHER MR. SINGH CAME TO OUR LEGAL AID CLINIC COMPLAINING THAT HER HOSTEL OWNER WAS CHARGING FEES FROM HER FOR THE LOCK DOWN PERIOD AND ALSO THREATENED HER THAT HE WILL NOT LET HER VACATE THE ROOM TILL THE TIME SHE PAY FULL FEES. SUGGESTION WAS GIVEN TO FILE A COMPLAINT IN COLLECTORATE OFFICE.
- 9. SCHOLARSHIP:** ONE OF THE STUDENTS CALLED AND TOLD THAT SHE HAS NOT YET RECEIVED HER SCHOLARSHIP AMOUNT. SUGGESTION WAS GIVEN TO CALL NODAL COLLEGE & CM HELPLINE.
- 10. CYBER CRIME (ID HACKED):** MS. APARNA, CALLED AND TOLD THAT HER SOCIAL MEDIA ACCOUNT HAS BEEN HACKED AND HACKER WAS ASKING MONEY FROM HER FRIENDS IMPOSING HIMSELF AS APARNA. SUGGESTION WAS GIVEN TO FILE COMPLAINT IN CYBER CELL OF POLICE DEPARTMENT.

11. **CHILD RIGHTS:** ONE DAY LEGAL AID CAMP WAS ORGANISED AT VILLAGE "TOLA CHOTA KHEDA" ON CHILD RIGHTS.
